4. Tuition for Basic Taxidermy and Techniques Is \$8,845.00. Application fee of \$150.00, for a total of \$8,995.00. Application fee and tuition must be paid in full at least 1 week prior to the start of the program.
5. East Coast Institute of Taxidermy does not provide room and board for students. Every effort will be taken by the school to assist students in finding living arrangements in the multiple hotels and motels in the area.
6. All books needed for the program will be supplied to the student by the school, at no extra cost to the student.
7. All supplies needed for the program will be supplied by the school, at no extra cost to the student.

9. East Coast Institute of Taxidermy reserves the right to cancel enrollment, if a student does not achieve the academic requirements established by the school. In the event the students enrollment is cancelled within the time frame of tuition reimbursement the student will receive as refund of the pro-rated amount. East Coast Institute of Taxidermy reserves the right to enforce and provide notice of rules as identified in the student hand book and regulations governing the conduct of a student while attending the school. Violation of any such rules and regulations will constitute grounds for dismissal of the student.
